

Pursuant to Article 17 of the Law on the Council of Ministers of Bosnia and Herzegovina (Official Gazette of BiH, 30/03, 42/03, 81/06, 76/07, 81/07, 94/07 and 24/08) and Article 11 paragraphs (2) and (3) point a) of the Decision on the system of coordination in the process of European integration in Bosnia and Herzegovina (Official Gazette of BiH, 72/16), at its 82nd session held on 23 November 2016, the Council of Ministers of Bosnia and Herzegovina adopted the following

DECISION
ON THE APPOINTMENT OF MEMBERS OF THE PERMANENT DELEGATION OF
BOSNIA AND HERZEGOVINA WITHIN THE STABILISATION AND ASSOCIATION
COUNCIL

Article 1
(Subject matter)

This Decision governs the composition and manner of operation of the Permanent Delegation of Bosnia and Herzegovina within the Stabilisation and Association Council (hereinafter: the Permanent Delegation).

Article 2
(Composition of the Permanent Delegation)

- (1) Members of the Permanent Delegation shall be:
- a) Chair of the Council of Ministers of Bosnia and Herzegovina,
 - b) Deputy Chairs of the Council of Ministers of Bosnia and Herzegovina,
 - c) Minister of Foreign Affairs of Bosnia and Herzegovina.
- (2) The Permanent Delegation shall be chaired by the Chair of the Council of Ministers of Bosnia and Herzegovina.

Article 3
(Manner of operation of the Permanent Delegation)

- (1) The Permanent Delegation shall operate in accordance with Decision (1) of the EU - Bosnia and Herzegovina Stabilisation and Association Council of 11 December 2015 on adoption of its rules of procedure (Official Gazette of BiH - International Agreements, 1/16).
- (2) The members of the Permanent Delegation shall represent and present exclusively the views and positions defined by the competent bodies in the system of coordination in the process of European integration in Bosnia and Herzegovina in accordance with Article 11 paragraph (5) of the Decision on the system of coordination in the process of European integration in Bosnia and Herzegovina (Official Gazette of BiH, 72/16).
- (3) The Chair of the Council of Ministers of Bosnia and Herzegovina shall appoint an official in the Mission of Bosnia and Herzegovina to the European Union who shall, together with an official of the General Secretariat of the Council of the European Union, act as secretaries of the

Stabilisation and Association Council pursuant to Article 5 of the Decision referred to in paragraph 1 of this Article.

(4) The Permanent Delegation Secretariat's affairs shall be carried out by the Mission of Bosnia and Herzegovina to the European Union and the Ministry of Foreign Affairs of Bosnia and Herzegovina

Article 4
(Entry into force)

This Decision shall enter into force on the day of its adoption and shall be published in the Official Gazette of Bosnia and Herzegovina.
