

Pursuant to Article 17 of the Law on the Council of Ministers of Bosnia and Herzegovina (Official Gazette of BiH, 30/03, 42/03, 81/06, 76/07, 81/07, 94/07 and 24/08) and Article 9 paragraph (6) of the Decision on the system of coordination in the process of European integration in Bosnia and Herzegovina (Official Gazette of BiH, 72/16), at the proposal of the Directorate for European Integration, the Council of Ministers of Bosnia and Herzegovina, at its extraordinary session held on 30 March 2017, adopted the following

**DECISION
ON THE ESTABLISHMENT OF THE WORKING GROUPS FOR EUROPEAN
INTEGRATION**

**Article 1
(Subject matter)**

The Decision on the establishment of the working groups for European Integration (hereinafter: the Decision) governs the establishment of the working groups for European integration in the system of coordination in the process of European integration in Bosnia and Herzegovina (hereinafter: the Working Groups) in line with the *acquis*, and stipulates their composition and mutual relations.

**Article 2
(Scope)**

(1) The Working Groups shall carry out the tasks referred to in Article 9 paragraph (8) of the Decision on the system of coordination in the process of European Integration in Bosnia and Herzegovina (Official Gazette of BiH, 72/16) (hereinafter: Decision on the system of coordination).

(2) For the purpose of effective implementation of tasks under the competence of the Working Groups, sub-groups may be formed whose composition and tasks shall be defined by the Working Group with the approval of the Commission for European Integration.

(3) The Working Groups shall not in any way replace the competent institutions from all levels of government in fulfilling the commitments of Bosnia and Herzegovina in the process of European integration.

**Article 3
(Composition and structure)**

(1) Pursuant to this Decision, 33 Working Groups shall be established in line with the *acquis*.

(2) The Working Groups shall consist of representatives of competent institutions, ministries and administrative bodies at all levels of government in Bosnia and Herzegovina, in line with their constitutional competence for respective areas that the Working Groups are established for.

(3) The following Working Groups shall be established:

Article 5
(Chair and deputies)

Each working group shall have a chair and two deputies and the chairmanship shall rotate every six months in the order of rotation set out in the Annex to this Decision.

Article 6
(Secretary and Directorate for European Integration)

(1) A nominated person coming from the institution of the chair, in cooperation with the Directorate for European Integration, shall act as a Secretary to the Working Group. Secretary shall not take part in decision making.

(2) The Directorate for European Integration shall monitor the work of the Working Groups and provide them with professional, technical and IT support.

Article 7
(Appointments and records)

(1) All Working Group members shall be appointed by the identified competent institutions from all levels of government in Bosnia and Herzegovina referred to in Article 4 of this Decision and the names shall be forwarded to the Commission for European Integration for final consolidation of the list of nominated representatives in the Working Groups

(2) The ministries, institutions and administrative bodies referred to in Article 4 of this Decision may change their representatives in the Working Groups and shall officially inform the Secretariat of the Commission for European Integration thereof.

(3) The Secretariat of the Commission for European Integration shall keep records on the Working Groups members with contact details and shall make it available to the Commission for European Integration and the chair, deputy chairs, members and secretary of the Working Group.

Article 8
(Experts participation)

(1) The chair of the Working Group, in agreement with their two deputies, may invite representatives of ministries and other administrative bodies in Bosnia and Herzegovina who are not members of the working group, representatives of non-governmental organisations, scientific workers, experts and other persons who have the information and professional knowledge relevant to the work of the Working Group to take part in the meeting.

(2) The persons referred to in paragraph (1) of this Article shall participate in the meeting of the Working Group as rapporteurs on respective items on the agenda and shall have no right to vote.

Article 9
(Relations between Working Groups)

(1) When a working group considers an issue partially falling within the scope of the work of other Working Groups, the chair, with the prior consent of two deputies, shall inform other working groups thereof and ask for their views, opinions or suggestions.

(2) The Working Groups shall respond to the request referred to in paragraph (1) of this Article, within 10 days of its receipt or sooner in the event of urgent matters.

(3) If the Working Groups cannot agree on an issue or if it is not clear which Working Group should consider the issue, the Commission for European Integration shall decide thereon.

Article 10
(Entry into Force)

This Decision shall enter into force on the day of its adoption and shall be published in the Official Gazette of Bosnia and Herzegovina.
