Na osnovu člana 70. st. (1), (3), i (6) Zakona o javnim nabavkama Bosne i Hercegovine („Službeni glasnik BiH“, broj 39/14) i člana 7. Pravilnika o postupku direktnog sporazuma Direkcije za evropske integracije, direktor Direkcije za evropske integracije donosi: / Pursuant to Article 70 paragraph (1), (3) and (6) of the Law on Public Procurement of BiH (Official Gazette of BiH, 39/14) and Article 7 of the Rulebook on the direct agreement procedure of the Directorate for European Integration of BiH, the Director of the Directorate for European Integration herewith issues the:

**ODLUKU**  
**o izboru najpovoljnijeg ponuđača /**  
**DECISION**  
**on selection of the most advantageous bidder**

**Član 1. / Article 1**

Na osnovu provedenog postupka nabavke putem direktnog sporazuma za pružanje usluga finansijske revizije, izabran je najpovoljniji ponuđač NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo, sa kojim će se zaključiti Ugovor za pružanje usluga finansijske revizije u iznosu od 3.500,00 KM bez PDV-a. / Under a direct agreement procedure for provision of financial audit services, the most advantageous bidder NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo was selected, with whom the Contract for provision of financial audit will be concluded in the amount of BAM 3 500 excluding VAT.

**Član 2. / Article 2**

(1) Ova Odluka će se objaviti na internet stranici Direkcije za evropske integracije te istovremeno uputiti ponuđaču NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo u skladu sa članom 70. stav (6) Zakona o javnim nabavkama Bosne i Hercegovine. / This Decision will be published on the website of the Directorate for European Integration, and at the same time it will be sent to the bidder NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo in accordance with Article 70 paragraph (6) of the Law on Public Procurements of BiH.

(2) Odluka stupa na snagu danom donošenja. / The Decision shall enter into force on the day of its adoption.

***Obrazloženje/Reasoning***

Odlukom o pokretanju postupka javne nabavke broj: 05-JN1-16-4-TB-43/20 od dana 19.08.2020. godine pokrenut je postupak javne nabavke za pružanje usluga finansijske revizije, putem direktnog sporazuma. Procijenjena vrijednost javne nabavke iznosila je 6.000,00 KM bez PDV-a. / The public procurement procedure for providing financial audit services

through the direct agreement was initiated by the Decision on the launch of public procurement procedure no. 05-JN1-16-4-TB-43/20 of 19 August 2020. Estimated value of the procurement amounted to BAM 6 000 excluding VAT.

U prethodnom periodu Ugovorni organ je proveo postupak javne nabavke za pružanje usluga finansijske revizije koji je poništen iz razloga što su ponude kvalifikovanih ponuđača dostavljene u istom iznosu. / In the past period, the Contracting Authority had conducted the public procurement procedure for provision of financial audit services, which was annulled because of the same amount of bids submitted by the qualified bidders.

Na osnovu navedenog pristupilo se poništenju postupka u skladu sa člana 69. stav (1) točka b) i stav (3) Zakona o javnim nabavkama BiH, odnosno postupak je poništen zbog dokazanih razloga koji su izvan kontrole Ugovornog organa i koji se nisu mogli predvidjeti u vrijeme pokretanja postupka javne nabavke. / Accordingly, the procedure was annulled in accordance with Article 69 paragraph (1) point b) and paragraph (3) of the Law on Public Procurement of BiH, due to proven reasons that are beyond control of the Contracting Authority, and could not be foreseen at the time of launching the public procurement procedure.

Zahtjev za dostavu ponuda za pružanje usluga finansijske revizije, putem direktnog sporazuma upućen je ponuđaču NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo. / A request for quotations of bids for provision of financial audit through a direct agreement was submitted to the bidder NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo.

Do krajnjeg roka za dostavu ponuda na Protokol Direkcije za evropske integracije, prispjela je ponuda ponuđača NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo. Nakon pregleda zaprimljene ponude, konstatuje se da je ponuđač u predmetnom postupku kvalifikovan, te da je uz dokaze kojima dokazuje da je zadovoljio uslove za učešće, dostavio i vrijednost svoje ponude u iznosu od 3.500,00 KM, bez PDV-a. / By the final time limit for accepting the bids at the Directorate for European Integration registry, the bid of the bidder NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo was received. After a review of the received bid, it was noted that the bidder was qualified and submitted the bid in the amount of BAM 3 500 excluding VAT along with the evidences proving his ability to meet the conditions for participation.

U skladu sa gore navedenim, a na osnovu kriterija „najniža cijena“ direktor Direkcije za evropske integracije donio je Odluku o izboru najpovoljnijeg ponuđača NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo sa kojim će se zaključiti Ugovor za pružanje usluga finansijske revizije u ukupnom iznosu od 3.500,00 KM bez PDV-a. / Accordingly, based on the criterion of the lowest price, the Director of the Directorate for European Integration passed the Decision on selection of the most advantageous bidder NGO and Business Audit društvo za reviziju i konsalting usluge d.o.o. Sarajevo, with whom the Contract for provision of financial audit services will be concluded in the total amount of BAM 3 500 excluding VAT.

## **POUKA O PRAVNOM LIJEKU / LEGAL REMEDY**

Protiv ove Odluke ponuđači nemaju pravo žalbe u skladu sa odredbama člana 101. Zakona o javnim nabavkama Bosne i Hercegovine („Službeni glasnik BiH“, broj 39/14), obzirom da je Odluka donijeta u postupku direktnog sporazuma. / In accordance with Article 101 of the Law on Public Procurement of BiH (Official Gazette of BiH, 39/14), bidders are not entitled to appeal against the Decision given that the Decision was issued within the direct agreement procedure.
