Na osnovu člana 70. st. (1), (4), i (6) Zakona o javnim nabavkama Bosne i Hercegovine („Službeni glasnik BiH“, broj 39/14) i člana 7. Pravilnika o postupku direktnog sporazuma Direkcije za evropske integracije, direktor Direkcije za evropske integracije donosi: / Pursuant to Article 70 paragraph (1), (4) and (6) of the Law on Public Procurement of BiH (Official Gazette of BiH, 39/14) and Article 7 of the Rulebook on the direct agreement procedure of the Directorate for European Integration of BiH, the Director of the Directorate for European Integration herewith issues the:

o poništenju postupka javne nabavke / DECISION on the annulment of public procurement procedure

Član 1. / Article 1

Poništava se postupak javne nabavke za pružanje usluga finansijske revizije putem direktnog sporazuma u skladu sa članom 69. stav (1) točka b) i stav (3) Zakona o javnim nabavkama BiH, odnosno zbog dokazanih razloga koji su izvan kontrole Ugovornog organa i koji se nisu mogli predvidjeti u vrijeme pokretanja postupka javne nabavke. / The public procurement procedure for providing financial audit services through the direct agreement shall be annulled, in accordance with Article 69 paragraph (1) point b) and paragraph (3) of the Law on Public Procurement of BiH, due to proven reasons that are beyond control of the Contracting Authority and could not be foreseen at the time of launching the public procurement procedure.

Član 2. / Article 2

(1) Ova Odluka će se objaviti na internet stranici Direkcije za evropske integracije te istovremeno uputiti svim učesnicima koji su učestvovali u postupku javne nabavke, u skladu sa članom 70. stav (6) Zakona. / In accordance with Article 70 paragraph (6) of the Law, the Decision shall be published on the website of the Directorate for European Integration and shall be submitted to all participants in the public procurement procedure at the same time.

(2) Odluka stupa na snagu danom donošenja. / The Decision shall enter into force on the day of its adoption.

Obrazloženje / Explanation

Odlukom o pokretanju postupka javne nabavke broj: 05-JN1-16-4-TB-40/20 od dana 10.08.2020. godine pokrenut je postupak javne nabavke za pružanje usluga finansijske revizije, putem direktnog sporazuma. Procijenjena vrijednost javne nabavke iznosila je 6.000,00 KM bez PDV-a. / The public procurement procedure for providing financial audit services through the direct agreement was initiated by the Decision on the launch of public procurement procedure no. 05-JN1-16-4-TB-40/20 of 10 August 2020. Estimated value of the procurement amounted to BAM 6 000 excluding VAT.
